Onnolee Nordstrom is an Assistant Professor in the College of Business at North Dakota State University. Her research has examined a variety of questions pertaining to entrepreneurship, family business, philanthropy and community development. Examples include: How does owning a business contribute to familial wellbeing? How do community morals and ethics influence enterprising activity? How do we inspire youth to become engaged in their community? Her work exploring these topics has been published in several academic journals and presented at numerous academic conferences. Her most recent research project has her involved in Fargo's entrepreneurial ecosystem. She is exploring the framing process within this ecosystem and the practices that have contributed to building an entrepreneurially conducive culture.

Ted Zoller is T.W. Lewis Distinguished Clinical Scholar and Professor of Strategy and Entrepreneurship. 
